Subject: Revision No. 5 to Appropriation No. 557 to Increase Funding from \$19,800,000 to \$40,000,000 to Finance all Estimated Costs of Site Preparation and All Costs in Advance of Award of Contracts for Expansion No. 2 and Related Facilities for the Mills Filtration Plant, and to Award a Contract

## Report

In January 1992, your Board approved Revision No. 4 to Appropriation No. 557 in the amount of \$19,800,000 to finance all estimated costs for environmental mitigation, procurement of steel pipe and fittings, and all estimated costs in advance of award of contracts for the Henry J. Mills Filtration Plant Expansion No. 2.

Bids have been received under Specifications No. 1237, as amended, for Site Preparation for Henry J. Mills Filtration Plant Expansion No. 2. Seven bids were received and opened. The proposals are shown on the attached Abstract of Bids. The low bid of Kiewit Pacific Company, in the amount of \$15,219,400, complies with the requirements of Specifications No. 1237, as amended, is \$719,400 over the Engineer's estimate and is \$432,400 below the next lowest bid. Kiewit Pacific Company is qualified to perform this work and has successfully completed other projects for Metropolitan.

The total estimated cost of the site preparation is \$22,000,000. The total estimated cost of environmental mitigation, procurement of District-furnished equipment and materials, site preparation, and construction of the expansion and related facilities for the Henry J. Mills Filtration Plant Expansion No. 2 is \$211,000,000. A \$20,200,000 increase in Appropriation No. 557 is now required for the site work. The breakdowns of the total estimated costs for Revisions Nos. 4 and 5 are shown on Attachment A.

All California Environmental Quality Act (CEQA) requirements have been satisfied for the proposed action. On February 11, 1991, your Board certified the Final Environmental Report for Expansion No. 2 of the Henry J. Mills Filtration Plant. This action satisfied the provisions of CEQA in regard to this matter and no further environmental documentation or review is necessary for your Board to take action on this request.

### Recommendations

#### FINANCE AND INSURANCE COMMITTEE FOR ACTION.

It is recommended that your Board authorize an increase of \$20,200,000 in Appropriation No. 557 from the 1991 Revenue Bond Construction Fund, to a total of \$40,000,000, for site preparation and for all estimated costs in advance of award of other construction contracts for the Henry J. Mills Filtration Plant Expansion No. 2.

## ENGINEERING AND OPERATIONS COMMITTEE FOR ACTION.

It is recommended that a contract in the amount of \$15,219,400 be awarded to Kiewit Pacific Company, for Site Preparation for Henry J. Mills Filtration Plant Expansion No. 2. and that, conditioned upon execution of the contract, all other bids be rejected.

### Specifications No. 1237, as Amended Site Preparation for Henry J. Mills Filtration Plant Expansion No. 2

The work under these specifications consists of excavations to competent material; refilling excavations with compacted engineered fill; installation of District-furnished equipment including large diameter pipe; furnishing and installing pipelines; removal and abandonment of underground pipe; dewatering; site preparation and grading; construction of an underdrain system; reservoir inlet and outlet structures with electric motor-operated sluice gates; connecting new pipelines to existing pipelines; and any other appurtenances, as required by the specifications. The work is to be completed within 250 working days after the contractor receives the Notice to Proceed. Under this schedule, the work should be completed by August 1993.

Engineer's Estimate: \$14,500,000.00
