Subject: Third Quarter Status Report on the Local Projects Program
Report

Pursuant to Administrative Code Section 2720, the following quarterly report on the status of the Local Projects Program (LPP) is submitted for your information. The LPP provides a financial contribution of \$154 per acre-foot to local agencies that develop and use reclaimed water that reduces a demand for Metropolitan's imported supplies.

In the third quarter of fiscal year 1992-93, agreements for the Cerritos Reclaimed Water Expansion Project, Encina Basin Water Reclamation Project Phase I, and Rancho Santa Fe Reclaimed Water System were executed.

Currently, the LPP has 32 approved projects which represent an ultimate yield of about 147,000 acre-feet per year (AFY). The LPP-approved projects are listed in Table 1. Twenty of these projects are in operation and receiving Metropolitan's LPP incentives. Since the inception of the LPP, Metropolitan has provided about \$6.3 million in incentives for the production of approximately 82,000 acre-feet of reclaimed water for landscape and golf course irrigation, nurseries, and industrial uses. Additionally, Metropolitan provided about \$9.9 million in capital financing for the South Laguna Reclamation Project and Las Virgenes Reclamation Project.

Four reclamation projects with a potential yield of about 30,400 AFY are currently under review. The status of these projects is summarized in Table 2.
