

- External Affairs June 2006 Activity Report

Summary

In June, the press office received about 20 news media calls and issued five press releases, including one issued jointly with U.S. Bureau of Reclamation on agreement for a demonstration program to determine whether Lake Mead can be used as a long-term water management tool on the lower Colorado River; one on the agreement with AFSCME; and another on the 2006 Telly Awards *Straight from the Tap* earned for programs on the Bay-Delta and the Global Water Forum. Metropolitan-related stories appeared in the *Business Press* (museums at DVL), *Inland Valley Daily Bulletin* (water-wise gardens), *Los Angeles Times* (water rates), *North County Times* (Father's Day event at DVL), *Pasadena Star News* (City Makeover event), *Press Enterprise*, *San Diego Union Tribune* (conservation, All-American Canal, Carlsbad desalination plant), and *San Gabriel Valley Tribune* (water bond). The education unit conducted five inspection trips, one to the Colorado River, one of the State Water Project and the remaining to Diamond Valley Lake, reaching 200 community members, provided in-service training to 51 teachers and DVL field trips for 212 students. There were more than 21 presentations on various topics to the public or legislative offices by staff. The district's Web sites received 73,605 hits during the same time. The community outreach group had \$219,226 in accumulated special events and activities sponsorships for the month for the following organizations: Building Industry Association, City of Whittier, Claremont Wildlands Conservancy, CREEC/TreePeople, Friends of Pio Pico, Habitat Authority, Latino Initiatives for the Next Century-The East Los Angeles Community Union Education Foundation, Los Angeles Business Council, and VICA. Diamond Valley Lake celebrated its 150,000 visitor since its October 2003 opening: Bill Connelly of El Cajon.

Initiatives

California Friendly™

Through a partnership with the U.S. Green Building Council, Metropolitan staff is conducting a pilot program combining its California Friendly Home standards with existing national green building standards. Following a June 8 workshop held at Eastern Municipal Water District, five new homebuilders agreed to participate in the pilot Leadership in Energy and Environmental Design for Homes program. All homes will begin construction this summer.

On June 28, General Manager Jeff Kightlinger met with Jim Previti of the Empire Companies to discuss growth and development in the Inland Empire and with John Young of Young Homes for a briefing on Metropolitan's long-term conservation needs and future goals for the residential housing market. Mr. Young was encouraged to use his leadership as the Southern California President of the Building Industry Association to persuade more builders and land developers to participate in Metropolitan's California Friendly programs.

Advertising for conservation rebate programs continued through June. Ten-second television ads ran during Los Angeles and San Diego sports events including baseball and basketball games and during golf tournaments. Print ads ran in *Better Homes & Gardens*, *Sunset Magazine*, *Time*, *Newsweek* and *California Landscaping*.

Dudek and Associates prevailed in a search conducted for a firm to develop and implement the California Friendly Homes certification program and was awarded a contract in late June.

Business and Community Outreach

The Press Office secured a major Los Angeles Times news story offering overview of the water management investments Metropolitan and its member agencies have made to keep pace with the region's growth. Metropolitan's conservation efforts, particularly our California Friendly initiative, were featured in the article.

Board Report (External Affairs June 2006 Activity Report)

The Business Outreach Program helped broker an agreement between Metropolitan and the U.S. Small Business Administration that will allow an exchange of resources, data, and programs that will help enhance opportunities for small businesses.

Legislative Outreach

Washington, D.C.

The House of Representatives will attempt to finish all appropriations bills before the July 4 recess. Thus far six bills (including the Interior and the Energy and Water Appropriations) have been passed and sent to the Senate. It is anticipated that once funding allocations are issued, the Senate Appropriations subcommittees will begin to deliberate on the appropriations bills before them.

On May 11, the House Energy and Water Development Appropriations Bill for FY 2007 was reported out which was \$546 million above the President's request but still \$172 million below FY 2006 level. The 10-year plan for CALFED calls for \$1.5 billion budget, of which 21% is federal funding. The federal participation averages out to be approximately \$31.5 million per year over ten years. In FY 06, the federal government funded CALFED at \$36.6 million. For FY 07, the President recommended \$38.6 million be included for CALFED programs. The House Energy and Water Appropriations bill for FY 07 contains \$40.1 million.

In the House Interior and Environment appropriations bill, the Bureau of Reclamation received an increase in funding over President's request but is still \$114 million below FY 2006 level. The bill does, however, include \$6 million to assess existing and future risks in the Bay-Delta.

Water Resources Development Act - The House bill, H.R. 2864, passed last July. Senate bill, S.728, is pending on Senate Calendar. Early this year 77 senators signed a letter to Majority Leader Bill Frist asking that S.728 be brought to floor for consideration. If a WRDA bill is brought up for consideration in the Senate, it won't be until after July 4 recess.

Legislation has been drafted and submitted to the Congressional Research Service for a summary to be reported to the Senate Energy Committee. Senators Dianne Feinstein (D-Ca) and Frank Murkowski (R-Alaska) should be introducing the legislation prior to the July recess. Chemical Facility Anti-Terrorism Act - S. 2145 would cause severe problems for those who supply drinking water, by forcing water utilities/agencies to comply with drinking water standards being imposed by the Department of Homeland Security, while still complying with EPA. Senator Ted Stevens (R-Alaska) has co-sponsored an amendment with Senators George Voinovich (R-Ohio), Robert Bennet (R-Utah), John Warner (R-WV) and Mark Pryor (D-Ar) to strip out the onerous provisions.

Sacramento

AB 2397 by Assemblyman Ron Calderon (D-Montebello) was pulled from the June 21 agenda of the Senate Local Government Committee. The bill was pulled by the author at the request of the bill's sponsors, AFSCME Local 1902, in light of successful contract resolution, the flood of letters in opposition to the bill and ongoing and productive discussions between Metropolitan management and AFSCME Local 1902 officers concerning future staffing levels.

In May, the Governor proposed that staff within the California Bay-Delta Authority be housed within the Resources Agency. In the course of negotiations on the Governor's FY 06/07 budget proposal, a compromise was struck to keep staffing levels within the Secretary of Resources "tight" by limiting the number of CBDA employees transferred to Resources Agency. In light of the short-term budget solution for CALFED, Assemblywoman Lois Wolk (D-Davis) has decided to withhold moving forward on her long-term governance bill, AB 1244, until next legislative session.

Senator Sheila Kuehl (D-Santa Monica), chair of the Senate Natural Resources and Water Committee, recently amended her bill, SB 1574, to require that the Secretary of the Resources Agency convene a cabinet-level committee to develop a "Blueprint for a Sustainable Sacramento-San Joaquin Delta." Metropolitan had concerns on the prior version of the bill, but the most recent amendments shift the focus of the bill and is consistent with policies adopted by Metropolitan's Board in April to support actions that promote an environmentally and

economically sustainable Delta. In light of the board's policy direction, Metropolitan will speak favorably to the bill when it is before the Assembly Water, Parks and Wildlife Committee on June 27.

Another measure of Senator Kuehl, SB 1640, was recently amended to address many of the concerns raised by groundwater purveyors around the state. Metropolitan, an early supporter of the bill, believes SB 1640 is designed to increase an understanding of water use in California and enhance the effectiveness and value of water resources planning and management that is key to future water supply reliability. The Assembly water policy committee will hear the bill on June 27.

Regional

Metropolitan sponsored the June 2 inaugural luncheon for the Inland Empire Affairs Network, where Governor Schwarzenegger's Cabinet Secretary Fred Aguiar was the keynote speaker. Metropolitan director David DeJesus and Chino Councilmember Eunice Ulloa attended.

More than 700 business and community leaders and elected officials attended Metropolitan's Community Water Conservation Festival June 3. Participants included member agencies, the Department of Water Resources, local water districts and water conservation vendors. The festival featured workshops designed to educate residents and commercial users on water-wise techniques such as creating and maintaining a California Friendly landscape, improving landscape irrigation, and incorporating composting methods.

Directors De Jesus, Pocklington, Record and Wright and staff toured Baja California, Mexico, June 6-8 to learn about water issues affecting the northern sector of Mexico and its respective environmental impacts to the overall region. The trip provided an opportunity for directors to dialogue with high-level state and federal water officials from the cities of Mexicali, Tecate, and Tijuana as well as with Baja state representatives from the agricultural and water interests.

More than 30 homebuilders and land developers attended the first partnership meeting between Metropolitan and the U. S. Green Building Council June 8 to promote water conservation in the Leadership in Energy and Environmental Design for Homes Program. Builders and land developers were encouraged to implement Metropolitan's California Friendly specifications for landscapes and in-door fixtures and appliances and were given extra credit in the program for their attendance.

Metropolitan sponsored or helped coordinate several large community events in June, including: a reception June 8 for elected officials as part of the Valley Industry and Commerce Association's Annual Gala Awards Dinner; a small business awards breakfast June 9 for the United Chambers of Commerce; the Riverside County Water Symposium on June 22, which was organized by Riverside County Supervisor Marion Ashley and hosted by Director Randy Record; and the Western Riverside Council of Governments Annual Assembly Dinner on June 29, which was attended by Director Terry Mylne.
