Express support for AB 1520 (Evans, D–Santa Rosa) – Statewide Watershed Program

**Description**

---

Assembly Bill 1520, as amended April 13, 2009 ([Attachment 1](#)), by Assembly Member Noreen Evans, Chair of the Assembly Budget Committee and sponsored by the Department of Conservation, would establish a voluntary and non-regulatory Statewide Watershed Program (Program) that would promote coordinated management of watersheds statewide and would provide technical and financial assistance to local community-based efforts in conservation, protection and restoration of the state’s watersheds. The Program would be under the authority of the Secretary of the Natural Resources Agency and the California Department of Conservation. The Secretary would create and appoint members to a State Watershed Advisory Committee (Committee) within the Department of Conservation, with the Committee operating in an advisory capacity only to assist the Secretary and the Director of the Department of Conservation regarding this Program. The Committee would include at least one member from each of the state’s ten Hydrologic Regions (as determined by the Department of Water Resources) with a maximum membership of 25 members. Committee members would be required to be familiar with and understand the community-based watershed efforts occurring in their region and may include representatives of a county, city, city and county, special district and stakeholder interests. Individuals appointed to the Committee would represent and further the interests of the state, their community and their watershed, in addition to serving the public interest. Members would serve two-year terms and may be reappointed by the Secretary for additional two-year terms.

The Program leadership and assistance would include: coordination and communication; information and data management; training and technical assistance; education; scientific assistance; and financial assistance. The financial assistance would include, but not be limited to, the awarding of grants to community-based programs for coordination of watershed assessment and planning, implementation of management plans and monitoring of watershed conditions and the effect of management practices on those conditions. Funding sources for the financial assistance are not identified, but the bill does note that provisions of this Program would only be implemented in a fiscal year for which funding is provided for that purpose in the annual Budget Act. The Department of Conservation would provide staffing and logistical support at the discretion of the Director, and may contract with a public or private entity to carry out prescribed activities. Every two years the Department of Conservation (in consultation with the Department of Fish and Game, the Department of Water Resources and any other applicable agencies) would submit a progress report on the Program to the Secretary.

Additionally, the Program would seek to increase collaboration among the various departments, boards, offices, authorities, commissions, conservancies and councils within the Natural Resources Agency and the California Environmental Protection Agency.

**Background**

The California Watershed Protection and Restoration Act, Public Resources Code, Division 5, Chapter 6.5, commencing with Section 5808 (AB 1405 by then-Assembly Member Lois Wolk, chaptered October 9, 2003), requires that: (1) the guidelines adopted by state agencies for use by local watershed partnerships shall provide flexible mechanisms to achieve quantifiable and monitored watershed objectives; (2) local jurisdictions may

participate in local watershed partnerships in order to ensure efficient, long-lasting and effective watershed restoration and management; and (3) state agencies with jurisdiction over watershed planning and protection may provide technical assistance to watershed management partnerships that are consistent with watershed protection laws and regulations, to the extent that funds are available.

Within the Budget Act of 2000, the Legislature established the Watershed Coordinator Grant Program (WCGP) to fund watershed coordinator positions throughout the state. The purpose of the program was to improve impaired watersheds by providing support for watershed improvement efforts at a local level. Proposition 84, The Safe Drinking Water, Water Quality and Supply, Flood Control, River and Coastal Protection Bond Act, approved by the voters in November 2006, authorizes up to \$10 million for the Department of Conservation for the WCGP.

### **Analysis**

Coordinated management of watersheds is a key element for sustainable water management in California. Significant watershed management efforts are pursued at the local community level and with effective planning and implementation, these efforts can improve water supply, water quality and overall watershed health, thereby supporting Metropolitan's ongoing source water protection efforts and enhancing water supply. Although this is a general statewide program and not aimed toward a particular watershed activity, creating a coordinated program for statewide technical and financial assistance for local efforts to improve watershed management within Metropolitan's watersheds should be generally supported. As was previously noted, funding sources for the financial assistance are not identified, but the bill does note that provisions of this Program would only be implemented in a fiscal year for which funding is provided in the annual Budget Act. A statewide watershed management program may better enable the distribution of such state funding.

### **California Environmental Quality Act (CEQA)**

In addition, where it can be seen with certainty that there is no possibility that the proposed action in question may have a significant effect on the environment, the proposed action is not subject to CEQA (Section 15061(b)(3) of the State CEQA Guidelines).

Adopt the CEQA determination and authorize the General Manager to express Metropolitan's support for AB 1520, as amended April 13, 2009.

**Fiscal Impact:** None

**Business Analysis:** Creating a coordinated program for statewide technical and financial assistance for local efforts to improve watershed management would provide water supply and source water quality benefits to Metropolitan, its member agencies and its subagencies through improvements to watersheds within Metropolitan's service area and to state watersheds within Metropolitan's sources of imported water supplies.

**Option #2**

Take no position on AB 1520, as amended April 13, 2009.


**Fiscal Impact:** None

**Business Analysis:** Lack of a coordinated statewide program for technical and financial assistance for local watershed management could result in increasing negative impacts on water supply and source water quality in watersheds within Metropolitan's service area and within Metropolitan's sources of imported water supplies and could delay implementation of projects to improve water supply and source water quality within these watersheds.

An act to add Chapter 6.6 (commencing with Section 5809.1) to Division 5 of the Public Resources Code, relating to watersheds.

LEGISLATIVE COUNSEL'S DIGEST

AB 1520, as amended, Evans. Statewide Watershed Program.

The California Watershed Protection and Restoration Act requires state agencies to adopt guidelines for use by local watershed partnerships to provide specified mechanisms and authorizes state agencies with jurisdiction over watershed planning and protection to provide technical assistance to watershed management partnerships, to the extent that funds are available.

This bill would establish the Statewide Watershed Program as a voluntary and nonregulatory program to provide ~~the means by which the state may provide~~ assistance and funds to local community-based efforts in the conservation, protection, and restoration of the state's watersheds and to promote coordinated management of watersheds under the authority of the Secretary of the Natural Resources Agency and the Department of Conservation.

The bill would create within the department a State Watershed Advisory Committee consisting of at least 10 members appointed by the secretary, with at least one member from each of the state's hydrologic regions, as specified, ~~and would authorize the secretary to appoint additional members and advisory persons to provide additional~~

~~assistance in the establishment, administration, or operation of the program.~~ The bill would authorize members to receive ~~per diem and mileage reimbursement for travel expenses~~ in accordance with specified rules and would prohibit the disclosure of proprietary information, except as specified.

The bill would also authorize the secretary to cooperate with the federal government, other states, and other state and local agencies in furtherance of the purposes of the program and would authorize the program to receive contributions or funds from specified private or public entities or persons. The bill would authorize the secretary to contract with any authoritative scientific body, as specified, ~~would exempt the expenditure of funds, the awarding of grants, and the adoption of guidelines from the California Environmental Quality Act (CEQA); and would exempt the adoption of guidelines, qualifications, or conditions from the Administrative Procedure Act.~~

*The bill would require that the provisions of the Statewide Watershed Program only be implemented in a fiscal year for which funding is provided in the annual Budget Act.*
