Express opposition to AB 1664 (Swanson, D-Oakland): Metropolitan Water District Act

Description

Introduced by Assembly Member Sandré R. Swanson (D-Oakland), chair of the Assembly Committee on Labor and Employment, Assembly Bill 1664 ([Attachment 1](#)) proposes to amend the Metropolitan Water District Act (MWD Act) to prohibit member agencies from directing or instructing their directors on how to vote on Metropolitan board matters.

As amended on April 5, 2010, AB 1664 would add a new section 51.5 to the MWD Act as follows:

Sec. 51.5. (a) The representative of a member public agency serving on the board shall at all times be authorized to represent the member public agency that appointed the representative.

(b) The governing body of the member public agency or an elected or appointed official or member of a member public agency shall not direct or instruct a member of the board to vote in a particular manner with respect to any question, order, resolution, or ordinance that comes before the board for a vote.

As written, AB 1664 is confusing and ambiguous. The author's intent is presumably to prohibit member agencies from mandating their respective directors to vote in a particular manner. However, although directors are appointed to Metropolitan's Board by their respective member agencies, they are already required to consider problems and issues from the standpoint of their Metropolitan responsibility. They also owe a fiduciary duty to Metropolitan and its interests. In this regard, AB 1664 is unnecessary.

Conversely, Metropolitan directors are appointed by their agencies to represent the agency's interests and should consult with their respective agencies and governing boards regarding Metropolitan decisions. AB 1664 could stifle the collaboration among Metropolitan directors and their appointing agencies and is improper. In this regard, AB 1664 could interfere with Metropolitan's and its member agencies' autonomy and could interject uncertainty into the roles and duties of a Metropolitan director.

Because AB 1664 is unnecessary and ambiguous, staff recommends Metropolitan oppose the bill as currently drafted.

Policy

Metropolitan Water District Act Sections 51, 52 and 54: Appointment of Directors

California Environmental Quality Act (CEQA)

LEGISLATIVE COUNSEL'S DIGEST

AB 1664, as amended, Swanson. ~~Vehicles: motorcycle trailers.~~ *Metropolitan Water District Act.*

The Metropolitan Water District Act provides for the creation of metropolitan water districts, governed by a board of directors composed of at least one representative of each member public agency appointed or selected by the member public agency, as prescribed.

This bill would require the representative of a member public agency serving on the board to at all times be authorized to represent the member public agency that appointed the representative. The bill would prohibit the governing body of the member public agency or an elected or appointed official or member of a member public agency from directing or instructing a member of the board to vote in a particular manner with respect to any question, order, resolution, or ordinance that comes before the board for a vote.

~~Existing law prohibits specified vehicles drawing other vehicles from traveling at a speed in excess of 55 miles per hour on a highway. Existing law requires those vehicles to travel in lanes designated by the Department of Transportation or local authorities under specified circumstances.~~
