Ethics Resource Center's 2007 National Government Ethics Survey® An Inside View of Public Sector Ethics

- Six out of ten government employees observed at least one form of misconduct in the past year.
- One in four government employees said they work in an environment conducive to misconduct.

Ethics Resource Center Report on Government - Good News

When a well-implemented ethics and compliance program and a strong ethical culture are in place, observations of misconduct are cut in half, and reporting rises by 40%.

SB 60 (1999) Required:

- Establishment of an Ethics Office with professional staff
- Ethics Office independence/reporting
- Ethics education for Directors and staff
- Creation of ethics rules, regulations, and policies
- Procedure for enforcement and schedule of penalties
- Procedure protecting confidentiality and protection of whistleblowers


