MWD Act Section 131 Background

- Section 131 provides for water sales to parties outside the Service Area
- Authorizes MWD to sell water to:
 - Government Agencies under 131(a)
 - Private Corporations or Public Agencies under 131(b)
- General limitations on terms and quantities

MWD Act Section 131(a)

- Authorizes MWD to sell water to:
 - State of California
 - United States Government
- MWD Administrative Code s4211 describes general terms for transactions under 131(a)

MWD Act Section 131(b)

- Authorizes MWD to sell water to:
 - Private Corporations
 - Public Agencies
- Only for the purpose of electric power generation
- A major portion of the electric power must benefit the MWD's Service Area

Project Description - Southern California Edison

- Construction and maintenance of a Transmission Substation
- Water supply needed for construction activity and ongoing maintenance
- Direct supply will come from a local well
- MWD supply contract will backstop local groundwater use

Why Does Southern California Edison Need a Backstop Supply

- Local groundwater pumping is within the Colorado River Accounting area
- Pumped water may, on occasion, be determined to come from the Colorado River
- Any water taken from Colorado River must be replaced
