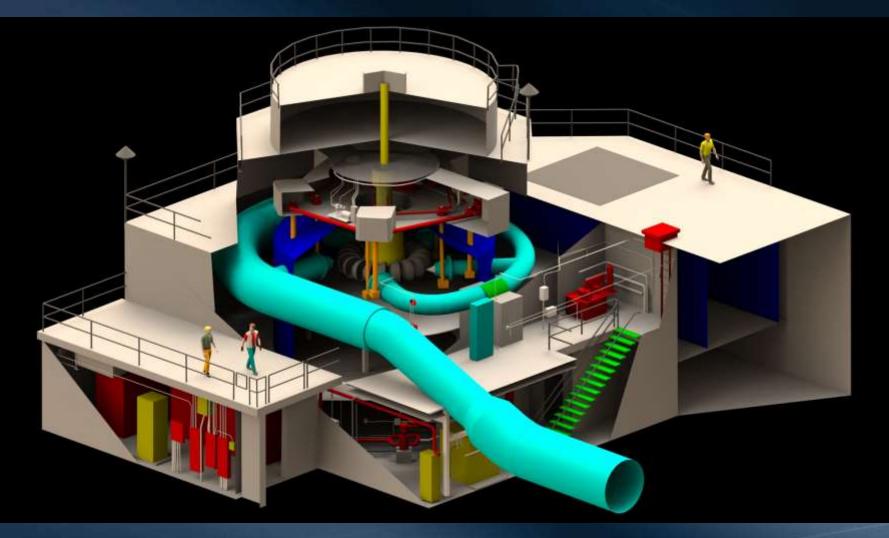


Yorba Linda Power Plant

CRA Copper Basin Outlet

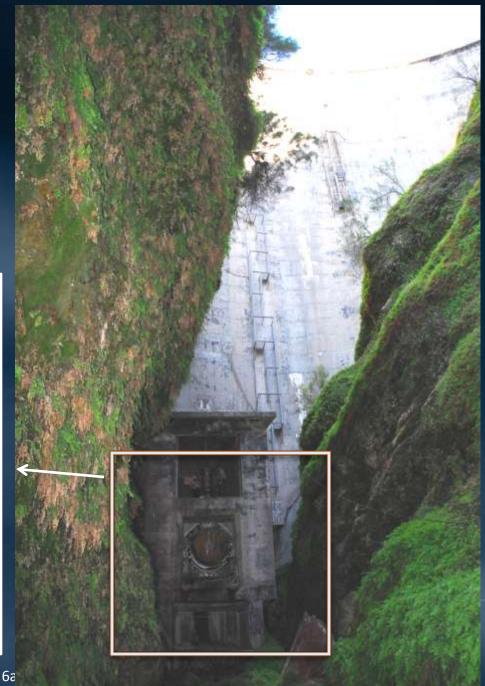

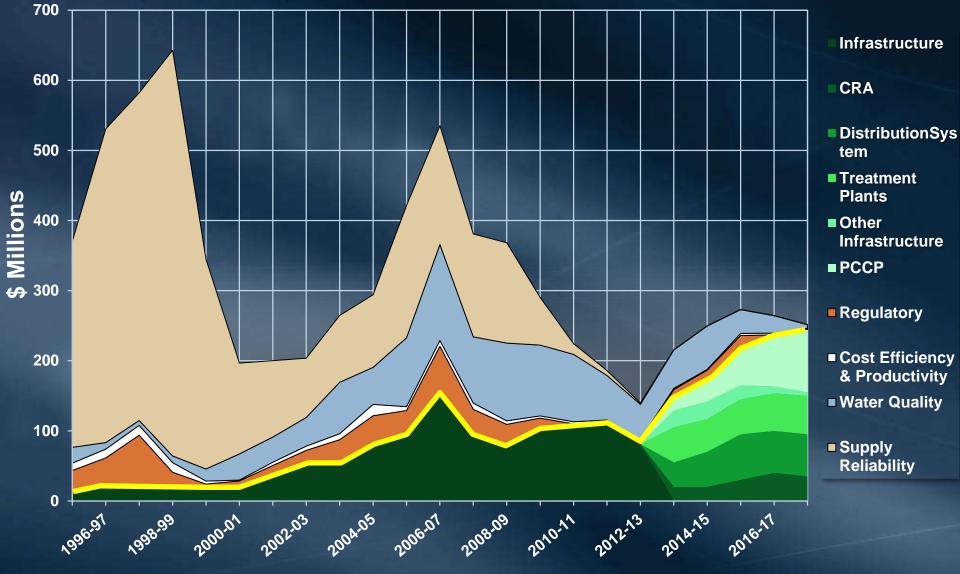
Objectives

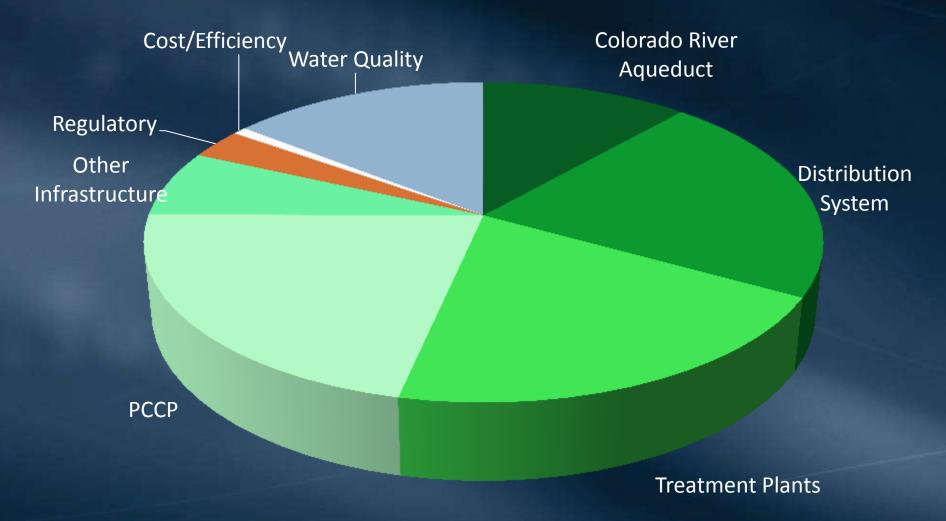

Capital Investment Plan FY 13/14 - Update 1995/96 - 2017/18

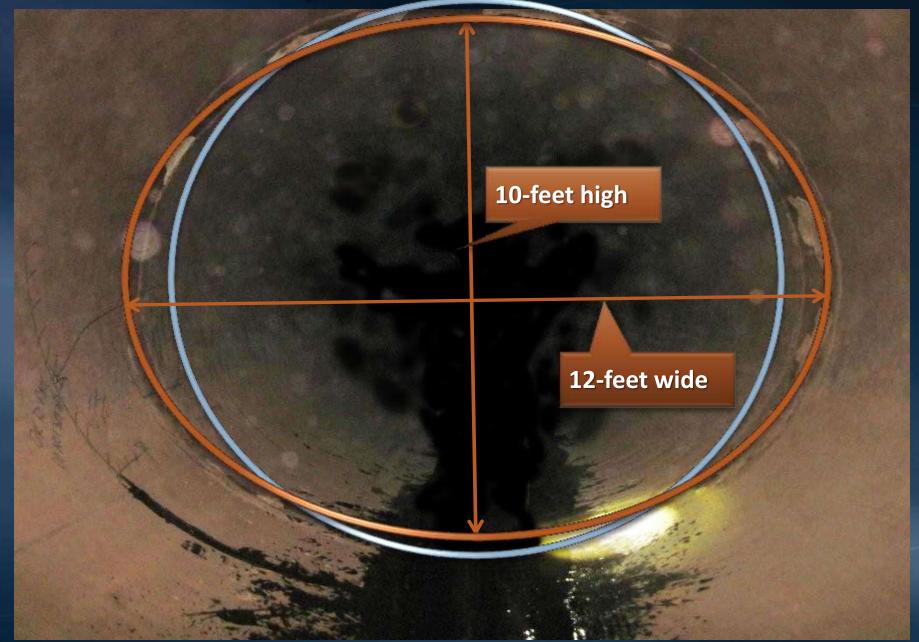


Capital Investment Plan FY 13/14 – Update FY 2013/14 – 2017/18
