50391 The Board of Directors of The Metropolitan Water District of Southern California met in Regular Meeting in the Board Room located in the building at 700 North Alameda Street in the City of Los Angeles, State of California, on Tuesday, March 8, 2016.

Chairman Record called the Meeting to order at 12:05 p.m.

50392 The Meeting was opened with an invocation by Silvia Lanza, Engineer, Engineering Services Group.

50393 The Pledge of Allegiance to the Flag was given by Director Donald Galleano.

50394 Board Secretary Morris called the roll. Board Secretary Morris declared a quorum present.

Minutes

50396 At 12:10 p.m., Chairman Record opened a public hearing to receive comments on (1) suspending the tax rate limitations in Section 124.5 of the Metropolitan Water District Act to maintain the ad valorem tax rate; and (2) proposed water rates and charges for calendar years 2017 and 2018 to meet revenue requirements.

Director Friedman requested that the record reflect that she recused herself from participating in the budget and rate-setting matters in accordance with advice from the Ethics Officer. She further requested that advice on the scope of the recusal be sought from the Fair Political Practices Commission.

Director Friedman withdrew from the Meeting at 12:13 p.m.

June Skillman, Manager, Budget and Financial Planning, provided a brief overview of the proposals to maintain the current ad valorem tax rate, and for the water rates and charges.

50398 A written report of meetings attended by Directors at Metropolitan expense during the month of February was distributed.

50399 There were no new committee assignments.

50400 Chairman Record referred to his written monthly report, which was distributed to the Board.

50401 Regarding matters relating to Metropolitan's operations and activities, General Manager Kightlinger referred to the General Manager's activity report for February dated February 29, 2016.

General Manager Kightlinger stated that June of this year will be the 75th anniversary of the first delivery of the Colorado River water to Southern California, and that staff is planning a full exhibit in the rotunda area. Also, State Historian Kevin Starr is scheduled to address the Board in June and speak on the history of water in Southern California and Metropolitan's role.

Regarding Legal Department activities, General Counsel Scully referred to the General Counsel's activity report for February dated March 1, 2016.

General Counsel Scully stated that last month she distributed to the Legal and Claims Committee a list of commonly used terms. The list is available as an app called "Met Wiki" that can be downloaded to cell phones from the Apple store.

50403 Deputy General Auditor Tonsick referred to the Audit Department's activity report for the month of February dated February 29, 2016.

Deputy General Auditor Tonsick stated that one audit report was issued regarding the purchasing of nonprofessional service contracts, which received a generally satisfactory opinion, and that management had addressed all the issues and concerns that were in the report.

50404 Ethics Officer Ghaly referred to the Ethics Department activity report for February 2016.

Ethics Officer Ghaly stated she will be sending out additional details on the conflict rule applicable to the budget adoption process. The Ethics Officer responded to Director Friedman's comments about the budget approval process. The Fair Political Practices Commission had sent a letter noting that under certain circumstances the conflict restrictions in a budget process could be broad, but could be addressed in the future by appropriate segmentation of the process.

Vice Chairman Touhey moved, seconded by Director Peterson, that the Board approve the Consent Calendar Items, M.I. 50405 through M.I. 50407, as follows:

Certify that the Final Environmental Impact Report (EIR) has been completed in compliance with CEQA and the State CEQA Guidelines; certify that the Board has reviewed and considered the information presented in the Final EIR, certify that the Final EIR reflects the Board's independent judgment and analysis; adopt the Findings of Fact and Mitigation Monitoring and Reporting Program; and (a) appropriate \$620,000 (Appropriation No. 15377, No. 38); and authorize (b) final design to rehabilitate a blow-off structure on the Orange County Feeder; and (c) increase of \$200,000 to an agreement with Dudek, for a new not-to-exceed total of \$485,000, as set forth in Agenda Item 7-1 board letter.

50406 Adopt the CEQA determination that the proposed action is categorically exempt, and (a) appropriate \$840,000 (Appropriation No. 15384, No. 10); and (b) authorize preliminary investigations to rehabilitate the auxiliary power systems at the Colorado River Aqueduct pumping plants, as set forth in Agenda Item 7-2 board letter.

50407 Adopt the CEQA determination that the proposed action was previously determined to be categorically exempt and not
