Subject: General Counsel's report of monthly activities

General Counsel Marcia Scully gave an update on the *Delta Stewardship Council* litigation, currently in trial. She also reported on a new Delta case filed by the North Coast Rivers Alliance. The committee watched a short video on active shooter scenarios, a topic of interest at a recent webinar event sponsored by the American Bar Association.

Ms. Scully answered questions from Directors regarding the Los Angeles Department of Water and Power Public Records Act litigation. Director Murray requested a report on fees expended in the *San Diego County Water Authority v. Metropolitan* case. Ms. Scully indicated that it would be put on the April agenda. Director Wunderlich suggested a water law tutorial for a future Legal and Claims Committee meeting. Director Murray inquired as to the status of the Delta diversions issue.
