# Distribution System



## Foothill Feeder

- 14.8 miles of tunnel & pipeline
- 5.9 mi. of 201 in. diameter PCCP
- Inspection of PCCP planned every 5-7 years
- Urgent repairs may be needed at any time
- Unique environmental issue
  - Dewatering requires discharge into Santa Clara River & tributaries
  - May impact fully-protected unarmored threespine stickleback





## **Dewatering Issues**

- Center for Biological Diversity v. Cal. Dept. of Fish & Wildlife (2015)
- Handling & relocation is prohibited form of take
- Risk of impacts to UTS affects reliable operation& maintenance
- In Feb. 2016 Board authorized staff to seek legislation allowing incidental take of UTS



## AB 2488 (Dababneh/Hertzberg)

- Signed into law by Gov. Brown on Sept. 16, 2016 effective Jan. 1, 2017
- Gives CDFW authority to issue permit to Metropolitan for incidental take of UTS
- Applies to dewatering, inspection, maintenance, modification, or repair, including emergency repair
- Long-term Incidental Take Permit to handle/rescue UTS ensures reliable operation of Foothill Feeder
- ITP requires environmental documentation, mitigation, & adaptive management

## Scope of Work

- Metropolitan Staff
  - Provide support for CEQA document & permitting
  - Conduct hydraulic analyses related to dewatering
  - Identify & negotiate mitigation for incidental take
- Dudek
  - Conduct biological surveys
  - Prepare CEQA document
  - Prepare permit application
- Dudek New Agreement
  - Selected based on specialized experience with UTS
  - Amount not to exceed \$750,000
  - SBE participation level 18%

#### Option #1
