## WSIP Background

#### **Program Goals**

Reach out to Com/Ind/Inst/Ag water users Provide Incentives for Custom Projects

Encourage Long-Term Water Management

May 2012, Board approved WSIP

- Pay-for-performance program
- Incentives up to \$195 per AF
- May not exceed half cost of the project

#### **Program Accomplishments**

- Total Executed Agreements: 121
- Total Funds Committed: \$3.8 M
  - Completed projects: \$1.34M
- Estimated Lifetime Water Savings: 24 TAF
- Average Cost Over Lifetime: \$163/AF







#### Incentives

- Up to \$0.60 / 1,000 gal saved per year (up to 10 yrs)
- Limited to 50% of eligible project costs
- Payments are phased
  - Final payment may be adjusted per monitoring results
  - Some projects may qualify for single payment based on detailed engineering plans

### **Performance of Completed Projects**

#### Top 20

- Comprise 90% of incentive payments
- \$1.2M in Metropolitan incentives
- 8,946 AF projected water savings
- Approximately \$134/AF unit cost
- All customers still exist / are in business
- 6 sites inspected within last year
- Favorable comments on performance



- Tri-Star Textile Dyeing and Finishing Inc.
- Proposed Project:
  - Installation of wastewater treatment and recycling plant on site
  - Multi-stage purification process to treat wastewater effluent for reuse in dye process





## Tri-Star Dyeing and Finishing Inc.

 Located in Santa Fe Springs
Central Basin MWD service area
16.8 M pounds of fabric processed annually
160 million gallons of water used annually



# **Project Technology**

- 1) pH Adjustment
- 2) Ozone Processing
- 3) Electro-Coagulation
- 4) Manganese greensand filter
- 5) Microfiltration system
- 6) Reverse Osmosis



## Estimated Savings & Incentives (10 Yrs)

	Target Reduction	Est. AF Savings	Est. Eligible Costs	Est. Incentive
Tri-Star Dyeing and Finishing Inc.	70%	3,538 AF	\$2.95M	\$692 K
