
This is a chance to consider an ethics office's intrinsic value and potential for assisting an organization. As one commentator put it:

"Compliance officers and their colleagues are responsible for helping all of the people in a company understand the difference between 'right' and 'wrong,' why they should care and how it is related to what they do.

"That may sound simple in theory, but the intricacies of how it is accomplished are more complex than you may realize. From cultural, behavioral, regulatory, and legal perspectives, right and wrong are not going to be the same for [different employees in different situations].

PROJECTS & INITIATIVES

The Ethics Officer and staff remain engaged in several projects and initiatives for review, analysis, and evaluation.

- ⇒ Support for outside review of Ethics Office policies and procedures.
- ⇒ Review of Investigation Guidelines and Processes
- ⇒ Collaboration with Human Resources and Information Technology on implementing new Conflict of Interest Code
- ⇒ Form 700 training course for new filers goes "live"
- ⇒ Modifying workflow of Form 700 electronic filing systems to accommodate new filers and disclosure categories

ADVICE & ASSISTANCE

The Ethics Office provides advice, educational materials, and other assistance to any director, officer, employee, or contractor regarding application or interpretation of Metropolitan's ethics rules and policies. Absent unusual circumstances, the Office provides its advice in writing.

The Ethics Office can provide advice only prospectively, i.e., about future activities. If it becomes apparent that a request for advice or other assistance concerns events that have already occurred, it might be necessary to review the matter as a potential violation.
