51174 The Board of Directors of The Metropolitan Water District of Southern California met in Regular Meeting in the Board Room located in the building at 700 North Alameda Street in the City of Los Angeles, State of California, on Tuesday, May 08, 2018.

Chairman Record called the Meeting to order at 12:00 p.m.

51175 The Meeting was opened with an invocation by Veena Konanur, Information Technology Group.

51176 The Pledge of Allegiance to the Flag was given by Director Morris

51177 Board Secretary Blois administered the roll call. 51178 Chairman Record invited members of the public to address the Board on matters within the Board's jurisdiction. Chris Clarke of the California Parks Conservation Association addressed the Board regarding the Cadiz ground water project. He also provided the Board with handouts that have been added to the digital archives.

51179 The Minutes of the Meeting of April 10, 2018 had been provided to each Director.

General Counsel Scully made a correction to the minutes to include the CEQA language of Option 2 for the California WaterFix vote (Minute Item 50846). Additionally, Director Hogan requested the following comments be added to the minutes:
