


How Cyclic Works in a Delivery Year



Program Implementation Review



Reviewed and executed cyclic storage and purchase agreements



Received and reviewed operating plans for FY 2017/18



Verified and processed monthly certifications of cyclic storage deliveries



Confirmed deliveries were in addition to agency's baseline operations



Confirmed purchases were made according to agreements



Followed required procedures (consistent with agreements and Metropolitan's Administrative Code)

Cyclic Program Implementation Highlights

- Met program goals
 - Successfully captured 120,000 acre-feet of supplies that would have been lost to the region
 - Increased local storage balances (and local emergency supply), improving water supply reliability for the region
- Met established requirements
 - Maintained consistency with Board's authorization, Metropolitan's Administrative Code, and other procedures
