#### 2021/2022 Insurance Market Outlook

- 21.8% Overall Cost Increase
- Factors Causing Insurance Premium Cost Spike and Coverage Capacity Decrease
  - Historic Catastrophic Wildfire Season
  - Multiple Years of Catastrophic Storm Damage
  - Economic Fallout from Covid-19 Pandemic
  - Escalating Jury Awards and Social Injustice Related Liability Settlements
  - Increasing Medical Costs
- Total Policy Renewal estimated to increase from



### OPTIONS

**Option #1** 

Approve up to \$1.594 million to purchase insurance coverage for Metropolitan's Property and Casualty Insurance Program to renew or replace all the expiring excess liability and specialty insurance policies for fiscal year 2021/22

#### Impact

A approximate \$285,200 cost increase compared to FY 2020/2021 Budget of \$1.45 million.

# OPTIONS Option #2

Approve up to \$1.549 million to purchase insurance coverage for Metropolitan's Property and Casualty Insurance Program to renew or replace all the expiring excess liability and specialty insurance policies but reduce the excess general liability coverage by \$15 million

#### Impact

Over the \$1.45 million budget resulting in a projected \$239,951 cost increase compared to FY 2020/2021, and reduces the excess general liability coverage by \$15 million

### **Staff Recommendation**

**Option #1** 

Approve up to \$1.594 million to purchase insurance coverage for Metropolitan's Property and Casualty Insurance Program to renew or replace all the expiring excess liability and specialty insurance policies for fiscal year 2021/22
