Metropolitan Cases

Palo Verde Irrigation District v. MWD (Riverside County Superior Court)

On March 16, 2018, the Palo Verde Irrigation District (PVID) voluntarily dismissed the CEQA action filed against Metropolitan in the Riverside County Superior Court. PVID originally filed this litigation in August 2017. In the suit, PVID asserted that Metropolitan violated CEQA when it determined that the approval and execution of six agricultural leases for the land that Metropolitan owns in the Palo Verde Valley was exempt from CEQA.

PVID subsequently amended the petition on September 29, adding two additional claims challenging Metropolitan's 2015 land purchase. These claims were later dismissed voluntarily by PVID on November 1.

On November 3, Metropolitan filed a demurrer (a motion to dismiss the case) arguing that the remaining CEQA claim was barred by the short 35day CEQA statute of limitations, and on December 12, the Riverside Superior Court granted Metropolitan's demurrer, with leave to amend.

On January 10, 2018, PVID filed an amended petition asserting the same CEQA claims and adding additional allegations to support their argument that Metropolitan should be estopped from relying on the statute of limitations because of alleged statements by Metropolitan staff that PVID asserted misled it into delaying filing the CEQA challenge more than six months after Metropolitan's Board approved the lease terms and authorized execution of the leases.

In January, PVID also submitted a Public Records Act request seeking documents related to one of the leases. The documents that Metropolitan produced, contained evidence contrary to the allegations in the amended petition. Metropolitan called PVID's attention to the facts and PVID dismissed the action with prejudice. The dismissal terminates this matter.

Mary Padres v. Metropolitan, et al. (Los Angeles County Superior Court)

Former Metropolitan employee Mary Padres filed a complaint for damages and other relief on March 21, 2018, in Los Angeles County Superior Court against Metropolitan. Plaintiff alleges three causes of action, of which two allege violations of the Fair Employment and Housing Act: sex discrimination and retaliation. The remaining cause of action alleges wrongful termination in violation of public policy. Plaintiff was released from her Metropolitan employment during her probationary period. The Legal Department is representing Metropolitan.

AFSCME Local 1902 v. Metropolitan (Public Employment Relations Board)

AFSCME Local 1902 filed an unfair practice charge on February 27, 2018, with the Public Employment Relations Board (PERB). The charge alleges Metropolitan violated the Mevers-Milias-Brown Act (MMBA) by failing to provide all the information requested by AFSCME Local 1902 in a written request for information dated May 22, 2017. As a remedy, AFSCME is seeking all information responsive to its request, a cease and desist order, and a notice posting Metropolitan's purported violation of the MMBA. On April 2, 2018, Metropolitan filed a position statement seeking a dismissal of the charge on the basis that it has fully complied with the MMBA concerning its responses to the request for information. The Legal Department is representing Metropolitan in this matter.

Brian May v. Metropolitan, et al. (Los Angeles County Superior Court)

As reported to the Board last month, Metropolitan employee Brian May filed a complaint for damages and other relief on April 13, 2017, in Los Angeles County Superior Court against Metropolitan. The complaint alleges five causes of action in violation of the Fair Employment and Housing Act:

- (1) disability discrimination; (2) retaliation;
- (3) failure to prevent unlawful discrimination;
- (4) failure to accommodate disability; and
- (5) failure to engage in the interactive process.

Metropolitan filed its answer denying the allegations on July 21, 2017. Based on the parties' stipulation, the trial date has been continued from July 23, 2018 to October 22, 2018. Atkinson
