Metropolitan Cases

OHL USA, Inc. v. Metropolitan (Los Angeles Superior Court)

On August 7, 2019, OHL USA, Inc. (OHL) filed a breach of contract complaint against Metropolitan relating to the Palos Verdes Reservoir Cover and Liner Replacement project. OHL alleges that Metropolitan failed to compensate it for extra work

and costs incurred due to Metropolitan-caused delays and interference with project work. OHL also alleges that Metropolitan failed to provide complete and accurate plans and specifications and required OHL to accelerate project work without compensation. The complaint seeks damages in excess of \$8 million, plus interest and attorneys' fees. Metropolitan's answer to the complaint is due October 9.

Matters Impacting Metropolitan

Maui County Council Votes to Settle Clean Water Act Case Pending Before the U.S. Supreme Court

On September 20, 2019, the Maui County Council voted 5-4 to settle the Clean Water Act (CWA) case County of Maui v. Hawaii Wildlife Fund that is scheduled for oral argument before the U.S. Supreme Court on November 6, 2019. However, there is a dispute regarding whether the Council or the Mayor, who opposes settlement, has the authority to settle the case. Lawyers with the Office of Council Services say the Council alone can settle the case, but Corporation Counsel lawyers, who represent the Council and the Mayor, state that both the Council and the Mayor have to agree on whether to settle. On September 25, County Council Chairwoman Kelly King sent a memo to Corporation Counsel asking that they execute the settlement agreement and take other necessary steps, including filing papers with the U.S. Supreme Court, to resolve the case.

The terms of the settlement would require the County of Maui to invest \$2.5 million in wastewater

reuse systems, to pay a \$100,000 penalty, and to make good faith efforts to get a National Pollutant Discharge Elimination System (NPDES) permit or an equivalent control document for the injection wells. The Mayor asserts that the settlement could cost the County more than \$800 million in fines, required improvements, and legal fees.

The question raised in *County of Maui* is whether the CWA covers discharges of pollutants from a point source which reach navigable waters through groundwater. If the *County of Maui* case settles, the Supreme Court could decide to hear a similar issue in another case pending before the Court, *Kinder Morgan Energy Partners, L.P. v. Upstate Forever.* In April 2018, the Fourth Circuit in *Upstate Forever* relied on *County of Maui* to find that a discharge of pollutants which travels through groundwater and reaches navigable waters through a direct hydrological connection requires an NPDES permit. Metropolitan staff will continue to monitor these cases. (See General Counsel's February and July 2019 Activity Reports.)
