





# **Metropolitan Cases**

# Systems Integrated, LLC v. Metropolitan (Los Angeles Superior Court)

On May 16, 2021, Systems Integrated, LLC (SI) filed an ex parte application for a temporary restraining order and order to show cause why a preliminary injunction should not issue. SI, which provides services related to Metropolitan's Supervisory Control and Data Acquisition (SCADA) system, alleged in its application that Metropolitan was disclosing SI's confidential, proprietary trade secrets and copyrighted materials to unauthorized individuals in violation of the parties' 2001 software license agreement. Metropolitan filed an opposition to the application and, following a hearing on May 19, the Court denied SI's ex parte application, finding that SI had "no reasonable prospect of success without expert testimony" and that SI had failed to provide sufficient evidence to justify a trade secret claim.

The application stemmed from a complaint filed by SI against Metropolitan on May 14, 2021. Metropolitan was served on May 27, eight days after the hearing. The complaint contains four causes of action—breach of the license agreement, infringement of common law copyright, misappropriation of trade secrets, and preliminary and permanent injunctive relief—and seeks unspecified general, special, punitive, and exemplary damages. Metropolitan's answer to the complaint is due on June 28.

#### Orange County Water District v. Northrop Corp., et al.; Northrop Grumman Systems Corp. v. Metropolitan, et al. (Orange County Superior Court)

At a Status Conference on May 7, 2021, the court discussed with the parties several issues regarding the next phase of trial, which will focus on the Orange County Water District's (OCWD) remaining claim for damages against Northrop under the Orange County Water District Act. The parties are to meet and confer to see which issues they can agree on and then file a Joint Status Report by June 24. The next Status Conference is scheduled for July 1.

OCWD originally filed this case in 2004 against multiple industrial defendants for contributing to contamination of the local groundwater basin. The industrial defendants filed cross-claims against Metropolitan alleging its deliveries of Colorado River water contained perchlorate, which contributed to the contamination. The defendants prevailed and OCWD appealed. The appellate court affirmed that none of the industrial defendants, except Northrop, were liable to OCWD. In 2017, the case was remanded to the trial court. The case was stayed from March 2018 until May 2019 to allow for settlement discussions. Trial was set for May 2020, moved to January 19, 2021, and then continued due to the pandemic. In January 2021, the court asked the parties to brief the scope of the next phase of trial and whether there should be a jury. No rulings have been made yet on these issues, and no new trial date has been set. The Legal Department will continue to monitor this matter.

# **Other Matters**

## Finance

On April 2, 2021, Metropolitan extended, until April 2024, the credit facility securing its \$271,815,000 of Special Variable Rate Water Revenue Refunding Bonds, 2020 Series B (Variable Rate Bonds). Legal Department staff attorneys assisted outside bond counsel with the drafting and negotiation of several contracts and closing certificates.

## Iron Mountain Landfill

Legal Department staff attorneys worked with Finance, Operational Safety and Regulatory Services, and the California Department of



Resources Recycling and Recovery to establish the legally required financial mechanism for postclosure maintenance and corrective action of the Iron Mountain Landfill. Legal Department staff attorneys were able to meet regulatory requirements with minimal changes to the existing Administrative Code and thereby avoided the expenditure of any additional Metropolitan funds.


#### **Continuing Education**
